Brief Description of Program

The Injury and Violence Prevention Branch (IVPB) mission is to promote and protect the health and well-being of all people in North Carolina by preventing injury and violence. In 2015 the Branch was awarded funding from the Centers for Disease Control and Prevention to implement the Prescription Drug Overdose for States (PfS).

The purpose of this funding is to advance and evaluate comprehensive state-level interventions for preventing prescription drug overuse, misuse, abuse, and overdose. Interventions of priority address drivers of the prescription drug overdose epidemic, particularly the misuse and inappropriate prescribing of opioid pain relievers. Priorities include prevention strategies to improve safe prescribing practices and prevent prescription drug overuse, misuse, abuse, and overdose. The four priority strategies are:

1. Enhance and maximize a state PDMP (Prescription Drug Monitoring Program).
2. Implement community or insurer/health system interventions aimed at preventing prescription drug overdose and abuse.
3. Conduct policy evaluations.
4. Develop and implement Rapid Response Projects.

Agencies Funded: Community based organizations, local health departments, and state universities.

PRESCRIPTION DRUG OVERDOSE FOR STATES PROGRAM

Services Provided by Agencies: Federal Funds are to be used for prescription drug overdose prevention.

Monitoring: Agencies participate on monthly calls; submit monthly expenditure reports; and mid-term and end of the contract year reports to report expenditures, activities and outcomes to the Program Supervisor.
