### **Brief Description of Program**

The North Carolina Immunization Program (NCIP) promotes a core public health function in North Carolina by preventing the spread of vaccine preventable diseases. The NCIP, in partnership with the CDC's National Center for Immunization and Respiratory Diseases (NCIRD), seeks to achieve the Healthy People 2020 Objectives which include the following immunization objectives: (1) Reducing indigenous cases of vaccine-preventable diseases (VPDs) to zero cases of diphtheria and tetanus among people aged 25 and younger; zero cases of polio, measles, rubella, and congenital rubella syndrome among people of all ages; 500 cases of mumps among people of all ages; and, 1,000 cases of pertussis among people of all ages by the year 2020; (2) ensure that 90% of children complete by age 2 the vaccine series recommended by the Advisory Committee on Immunization Practices (ACIP);

(3) Increase immunization levels for pneumococcal and influenza to at least 60 percent among non-institutionalized high-risk populations as defined by the ACIP.

Local health departments will support the North Carolina Immunization Program (NCIP) in reaching that goal by working together to accomplish the following objectives as supported by Healthy People-2020:

- 1. By the year 2020, increase the age-appropriate immunization levels of two-year old children to 90% or more; and
- 2. By the year 2020, assure that at least 95% of North Carolina children (0 to 18 years old) are represented in the North Carolina Immunization Registry (NCIR).
